NOTIFICATION

DECLARATION

No.K-12011/17/93-REV. the 8th June, 1993. Whereas by Government Notification No. LRR-290/61/112 Dt.10.9.1991 published in the official Gazette and two daily local newspapers, it was notified under Section 4 of the Land Acquisition Act, 1894 (Central Act I of 1894) (hereinafter raferred to has the "said Act") that the land specified in the schedule appended to the said Notification was likely to be needed for the public purpose namely Land Acquisition for SUBMERGENT AREA OF SERLUI 'B' HYDEL PROJECT UNDER POWER & ELECTRICITY DEPARTMENT.

And whereas the appropriate Government (hereinafter referred to as the "Government of Mizoram") after considering the report made under sub-section (2) of the Section 5 (A) of the said Act-needed for the public purpose specified bove.

Now, therefore, the Covernment declares under Section 6 of the said Act that the said land is required for the public purpose specified above.

The Government also appoints, under clause (c) of Section 3 of the said Act the Collector. Aizawl District to perform the functions of a Collector, Aizawl District for the proceedings hereinafter to be taken in respect of the said land and directs him under Section 7 of the said Act to take order for the acquisition of the said land.

The Collector shall there upon cause the land to be measured and make a plan of the same under section 8 of the said Act if not already done as per Section 4 of the said Act, and dispose of all objections and claims after causing a public notice of not less than 15 days to the persons interested at convenient places on or near the land to be taken, stating the Government intention of taking over the possession of the said land as per Section 9 of the said Act.
