### NOTIFICATION

No. B. 11013/73/90-TRP, the 9th September, 1993. Whereas a draft reciprocal agreement between the Govt. of the State of Tripura and the Govt. of the State of Mizoram in pursuance of sub-section (5) of Section 88 of the M.V. Act, 1928 (Act 59 of 1988) was published in the Mizoram Gazette (Extra ordinary) Vol. XXII Issue No. 14 dt. 4.2.93 inviting any objections or suggestions to be affected thereby within 30(Thirty) days from the date of publication of the said Notification in the official gazette:

And whereas no objection/suggestion have been received from any person;

Now, therefore, in exercise of the powers conferred by sub-section 6 of Section 88 of the M. V. Act, 1988, the Govt. of Mizoram is pleased to publish below the Reciprocal Agreement arrived at between the Govt. of the State of Tripura and the Govt. of the State of Mizoram.

RECIPROCAL AGREEMENT BETWEEN THE GOVERNMENT OF THE STATE OF MIZORAM AND THE GOVERNMENT OF THE STATE OF TRIPURA.

An agreement made this day of one thousand nine hundred and ninety three, between the Governor of the state of Mizoram on the One Part and Governor of State of Tripura on the Other Part. for the purpose of the proviso to Sub-Section (4) of Section 88 of the Motor Vehicles Act, 1988.

1. This Agreement shall come into effect on 9.3.1993 and continue to be operative till it is replaced by a fresh agreement by mutual consent. It may be rescinded by either party on giving to the other prior notice of 3(three) months with reasons therefore for terms and conditions hereby agreed to between the parties are in regard to the grant of permits to vehicles for plying the State of either party and are set forth hereunder, namely:

# 2. STAGE CARRIAGE PERMITS:

Authorities concerned in the party may grant stage carriage permits to vehicles originating from their respective States belonging to Transport Undertaking/Corporation which shall not exceed the number noted against each on the following routes:—

1. Agartala to Aizawl and vice versa.

2. Aizawl to Vanghmun (Tripura) and vice versa.

# 3. TEMPORARY PERMITS

The authorities concerned in each party State grant without any restriction as to the number, temporary permits for Public Vehicles and Public Carriers under Sub-Section (7) of Section 88 of the Motor Vehicles Act, 1988 for plying in the other State for the purpose as mentioned under Sub-Section (1) of Section 87 of the Motor Vehicles Act, 1988, namely:—

- (a) for the conveyance of passengers on special occasions such as to and from fairs and religious gatherings. Sports Meet;
- (b) for the purposes of a seasonal business;
- (c) to meet a particularly temporary need; or
- (d) pending decision on an application, for the renewal of a permit.

Provided that such permits shall be issued for a period not exceeding 10 days, and for one round trip only.

# 4. CORRIDOR FACILITY:

Where the route of a State Carriage Bus from an initial point to a terminal point in the State passes through the territory of the other party State, each of such party States shall allow the vehicle to pass through its territory provided that the vehicle shall not drop or pick up passengers at any place within the reciprocating State.

# 5, CONDITIONS RELATING TO PERMITS:

- a) The grant of permits by each party state shall not exceed the quota fixed for it under this agreeement.
- b) The grant of permits for stage Carriage Buses as stipulated in Clause 2, shall each be on periodic basis.
- c) All the permits issued by the authorities concerned of the Home State except the temporary permits are to be countersigned by the Authority concerned of the other party. The countersignature for the temporary of periodic permits will be for the full period of validity of the permits issued by the Home State.
- d) The authority concerned of either Party State shall be at liberty to withdraw the countersignature given for any permit or permits if they create any practical difficulties in operation due to time table, road conditions, law and order situation or any other factor, such withdrawal of countersignature shall immediately be intimated to the Home State by other party State.

# 6. GENERAL

- a) Both party States shall accord recognition to tax token, Registration and other certificates of the vehicles Driving licences, Conductor's licences and certificate of fitness granted by either of them, to the vehicle which ply in each other's territory in terms of this agreement.
- b) In granting 'State Carriage Permits' both States agree to grant preference to vehicles of the State Transport Corporation of State Transport Undertaking.
- (c) In case, any difficulty arises in the course of operation of this agreement, both states agree to resolve it through mutual consultations.
