### NOTIFICATION

No.308/MIZ-LA/93 :- Whereas, in pursuance of Notification No.H. 11014/1/93-GAD, issued by the Governor of Mizoram on the 30th October, 1993, under sub-section (2) of Section 15 of the Representation of the People Act, 1951 (43 of 1951), a general election has been held for the purpose of constituting a new Legislative Assembly for the State of Mizoram;
