NOTIFICATION

No. A. 12018/6/85-P&AR (GSW), the 10th December, 1993. In exercise of the powers conferred by the proviso to Article 309 read with Articles 233 and 234, Chapter VI, Part VI of the Constitution of India, the Governor of Mizoram is pleased to amend, in consultation with the Gauhati High Court, the Mizoram Judicial Service Rules, 1989 namely :—

1. Short title and commencement :
 - i) These Rules may be called the Mizoram Judicial Service (First amendment) Rules, 1993.
 - ii) They shall come into force from the date of publication in the Gazette.
2. Amendment of Rule 23 (1) (a) : The time-scale of pay Admissible to a member of the Service in Grade I Senior shall be "Rs. 5100-150-6150/-".
3. Substitution of Schedule 'A' : Schedule 'A' (Authorised Permanent Strength) of the Mizoram Judicial Service Rules, 1989 shall be substituted by the following namely :—
