NOTIFICATION

S.O. 817(E) – In exercise of the powers conferred by section 28 of the Representation of the People Act, 1950 (43 Of 1950), consulting the Election Commission, hereby makes the following rules further to amend the Registration of Electors Rules, 1960, namely :—

1. (1) These rules may be called the Registration of Electors (Second Amendment) Rules, 1993.
- (2) They shall come into force on the date of their publication in the Official Gazette.
2. In the Registration of Electors Rules, 1960—
 - (1) In rule 13, —
 - (a) in sub-rule (1) —
 - (i) in clause (a), the word “and” shall be inserted at the end;
 - (ii) in clause (b),
omitted;
 - (iii) clause (c) shall be omitted;
 - (b) in sub-rule (2) —
 - (i) in clause (a) the word “and” shall be inserted at the end;
 - (ii) in clause (b) the word “and” occurring at the end shall be omitted;
 - (iii) clause (c) shall be omitted;

(2) In rule 26, sub-rule (1B) shall be omitted;

(3) In Form 6, the words "I am an elector in the electoral roll in which the claimant applied for inclusion and my name is enrolled at Serial No in Part No of the roll. I support this claim and countersign it.

(4) In Form 7, the words "I am an elector included in the electoral roll in which the name objected to appear and my name is enrolled at Serial No... in Part No of the roll. I support this objection and countersign it.
