NOTIFICATION

RULES FOR THE GRANT OF SUBSIDIES UNDER THE SERICULTURE DEPARTMENT, MIZORAM, 1994

Whereas the Government of Mizoram deems it expedient to extend adequate assistance within the limits of its financial resources in the shape of subsidy to the deserving private Sericulturists. The Governor of Mizoram is hereby pleased to make the following rules, namely :-

1. SHORT TITLE, EXTENT AND COMMENCEMENT

- 1) These rules shall be called the "Mizoram Sericultural Subsidies Rules, 1994".
- 2) They shall apply to all persons residing permanently in Mizoram, who are willing to start, expand, modernise or diversify any of the following, namely :-
 - a) Mulberry Plantation;
 - b) Silkworm Rearing;
 - c) Silk Reeling,
 - d) Silk Spinning,
 - e) Silk Quilt and Carpet Making,
 - f) Silk Weaving,
- 3) They shall come into force with immediate effect.

2. DEFINITIONS :

In these rules, unless the context otherwise requires :-

- a) Actual cost means actual investment made on building, plant and machinery etc., by a Sericulturist;

- E) Subsidy on Construction — 50 per cent of the actual cost incurred by the beneficiary for the construction of Rearing House of his own upto a maximum of Rs 8,000/-

6. APPLICATION FORM :

Application for grant of subsidy on the cost of above items under rule 4 shall be submitted in duplicate by the applicant to the concerned District Office in the prescribed form as per Appendix 'A'.

7. MODE OF SELECTION OF BENEFICIARIES AND SANCTION :

- 1) Application for grant of respective subsidies shall be made as per prescribed application Form as specified in Appendix 'A'.
- 2) Each and every application shall be supported with relevant Voucher(s)/ Receipt(s) and other necessary certificates/documents as specified in the prescribed application form under Appendix 'A'.
- 3) On receipt of application, necessary inquiry/verification shall be made by the concerned District Office and if found eligible, the original copy of the application with its enclosures shall be forwarded to the Director with recommendation alongwith a consolidated list.
- 4) There shall be a State Level Committee constituted by the Government for the subsidy schemes as specified under rule 4 for advising and assisting the government in the selection of applications eligible for the subsidies.
- 5) The Director shall prepare consolidated statement of the cases proposed in order of merit for consideration of granting subsidy and shall place before the committee for scrutiny and approval.
- 6) The Committee shall scrutinise the applications and select the applicants who are eligible for the subsidy and also set guidelines and priorities in selecting applicants on the basis of recommendation of the committee. The Director shall submit to the Government, the proposal for sanction of the subsidy clearly indicating the names of individual beneficiaries and amount of subsidy recommended against each beneficiaries supported by a copy of the minutes of the committee.
- 7) The case of eligible beneficiary left out, if any due to limitation of budget provision in a particular year, these shall be considered on the basis of priority in the next financial year.

8. SELECTION COMMITTEE :

DISBURSEMENT OF SUBSIDY UTILISATION AND MONITORING

(1) On obtaining sanction, the Director shall draw the amount and transfer to the concerned District Officer through Bank Draft who shall ultimately disburse the concerned beneficiaries personally. The District Officer disbursing the subsidy shall maintain a separate Register for each and every subsidy scheme in which he shall enter the names of individual beneficiaries receiving the subsidy with the amount of subsidy received.

(2) The grantee receiving subsidy shall give an undertaking in Appendix 'B' to the effect
fied in these rules after receiving subsidy.

(3) In the event of non-fulfilment of the above conditions, the entire subsidy amount disbursed to the defaulting beneficiaries shall be realised from him by the Government.

(4) The beneficiary shall make an agreement in Appendix 'C' that in the case of false information and use of fake documents, he shall refund the entire subsidy amount disbursed to him to the Government.

(5) The concerned District Officer or his nominee shall keep Vigilance over the facts and figures submitted by each beneficiary of his jurisdiction so that no falsification of documents are entertained for grant of subsidy.

0. INTERPRETATION :

In any matter of doubt arising out of any of these rules, the interpretation by and decision of the Government shall be final.
