The draft reciprocal agreement together with any objections or suggestions shall be taken into consideration after the expiry of the stipulated period of 30 (thirty) days from the publication of this Notification in the Official Gazette.

# DRAFT RECIPROCAL/SPECIAL AGREEMENT BETWEEN GOVERNMENT OF MIZORAM AND GOVERNMENT OF ASSAM

This agreement made ...... between the Govt, of the State of Mizoram on the one part and the Govt, of the State of Assam on the other part for the purpose of promoting tourism in terms of sub-section (5) and (9) of Section 88 of Motor Vehicle Act, 1988.

# 1. MIZORAM STATE TRANSPORT DIRECT BUS SERVICE TO GUWAHATI

The Mizoram State Government will introduce direct Mizoram State Transport (Deluxe Coach) Bus service upto Guwahati subject to payment of taxes to the Governments of Assam and Meghalaya.

## 2. ROUTE KM FARE:

- (a) The route from Aizawl to Guwahati via Shillong is 540 kms.
- (b) The fare shall be Rs. 0.40 paise per Km per passenger and Rs. 200/for direct passenger.

### 3. BOOKING COUNTER:

Ticket booking counter shall be installed in the offices of the Liaison Officers, of Govt. of Mizoram at Guwahati and Shillong. The Liaison Officer, Guwahati will provide accommodation to the Drivers and Conductors of the vehicles in the Mizoram House itself and in case of Shillong, the accommodation provided by Meghalaya Transport Corporation as before will be availed of since no reservation in the Mizoram House at Shillong is possible for want of accommodation at prerent.

### 4. REPAIR OF BUSES:

- (a) In cases the buses require to be attended to for minnor repair/breakdown etc. it shall be done by the Transport Undertaking of the State of Assam.
- (b) The Transport Undertaking of Govt. of Assam shall provide necessary refuelling facilities for the return journey of the Bus
- (c) Expenditure incurred against (a) & (b) above may be submitted to the State Transport Undertaking of the Government of Mizoram for payment/reimbursement.

#### 5. INFORMATION:

As and when adverse law and order situation arises in the State involving operation of the Bus services, such information shall be passed on by the reciprocating State by telephone or crash message and it shall also be ensured safety and security of the passengers and the buses.

6. It was further agreed to start the bus service once in a week initially and the frequency may be increased later on depending on demand/necessity.
