Short title

Issue of Rs. 591,70,18 000.00 from and out of the Consolidated Fund of the State of Mizoram for the financial year 1994-95

- 1. This Act may be called the Mizoram Appropriation (No. 2) Act, 1994.
- 2. From and out of the Consolidated Fund of the State of Mizoram, there may be paid and be applied sums not exceeding those specified in Column 3 of the Schedule amounting in the aggregate to the sums of Rupees five hundred ninety one crore seventy lakh eighteen thousand only towards defraying the several charges which will come in course of payment during the financial year 1994-95 in respect of the services specified in Column 2 of the Schedule.

Appropriation

3. The sums authorised to be paid and applied from and out of the Consolidated Fund of the State of Mizoram by this Act shall be appropriated for the services and purposes expressed in the Schedule in relation to the said year.
