## NOTIFICATION

No. H. 12018/9/91-LJD, the 29th March, 1994. The following Act of the Mizoram Legislative Assembly, which received the assent of the Governor of Mizoram is hereby published for general information.

The Mizoram Act No. 5 of 1994

The Mizoram Salaries, Allowances and Pension of Member of the Legislative Assembly (Amendment) Act, 1994.

(Received the assent of the Governor of Mizoram on the 28th March, 1994)

AN

ACT

further to amend the Mizoram Salaries, Allowances and Pension of the Members of the Legislative Assembly Act, 1987

Be it enacted by the Legislative Assembly of the State of Mizoram in the Forty-fifth year of the Republic of India as follows :—

Short title and commencement 1. (1) This Act may be called the Mizoram Salaries, Allowances and Pension of the Members of the Legislative Assembly (Amendment) Act, 1994.

(2) It shall be deemed to have come into force with effect from the first day of April, 1991.

Amendment of section 3 2. In the Mizoram Salaries, Allowances and Pension of the Members of the Legislative Assembly Act, 1987 (Act No. 6 of 1987), as amended from time to time (hereinafter referred to as the Principal Act), in section 3, in between the words "period of residence" and "for the meeting", the words "and of journey" shall be inserted.

Amendment of section 5 3. In the principal Act, in sub-section (1) of section 5, for the words "at the rate of Rs. 150/- per day (No separate sitting and daily allowance)" the words "a reimbursement of the actual fare in any bus of the journey and if a Member uses his own car, he shall be entitled to a reimbursement at the rate of Rs. 4/- per kilometre," shall be substituted.

Amendment of section 8 4. In the principal Act, for section 8, the following section shall be substituted, namely :—

"Travel by air, train or by road 8. A member shall be entitled to travel by air or train or by road on tour for performing official duties within India".
