NOTIFICATION

No. A. 12018/12/87-PAR(GS), the 26th October, 1994. In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Mizoram is pleased to make the following rules relating to the recruitment to the posts indicated in the Annexure-1.

- 1. Short title and commencement:
- (i) These rules may be called the Mizoram Power & Electricity Department (Group 'A' posts) Recruitment Rules, 1994.

(ii) They shall come into force on the date of their publication in the Official Gazette.

- 2. Application: The Rules shall apply to the post specified in Col. 1 of the Annexure-I hereto annexed.
- 3. Number of posts, classification and scale of pay:

4. Method of recruitment age limit and other qualification:

The number of the said post(s), their classification and the scale of pay attached thereto shall be as specified in the Annexure-1 aforesaid.

The age limit, qualification and other matters relating to the said post, shall be as specified in the Annexure-1.

Provided that the upper age limit prescribed for direct recruitment may be relaxed in the case of candidates belonging to the Scheduled Castes, the scheduled tribes and other special categories of persons in accordance with the orders issued by the Central Govt. or Govt. of Mizoram from time to time.

- Disqualification: 5.
 - No person,
 - (a) Who has entered into or contracted a marriage with any person having a spouse living; or
 - (b) Who, having a spouse living has entered into or contracted marriage with any other persons, shall be eligible for appointment to the said post.

Provided that the Governor may, if satisfied that such marriage is permissible under the personal law applicable to such person and to other party to the marriage and that there are other grounds for doing so, exempt anyperson from the operation of this Rule.

- The person recruited under these Rules shall undergo such traiping or pass such Departmental Examination as may be prescribed from time to time.
 - Notwithstanding anything contained in these Rules, the Governor of Mizoram, in public interest, have the right and power to transfer any Officer or Official, recruited in accordance with these Rules to the post/posts/ service specified the Annexure to these rules to any other post or position which is equivalent in rank or grade,
- Where the Governor is of the opinion that it is necessary or expedient so to do, he may, by order and for reasons to be recorded in writing relax any of the provisions of these Rules with respect to any class or category of persons.

9. Reservation, other Nothing in these rules shall affect concessions required to be provided for the Scheduled Caste, concessions. Scheduled Tribes and other categories of persons in accordance with the orders issued by the Central Govt. or Govt. of Mizoram from time to time in this regards.

All the Rules pertaining to the recruitment to the posts still 10. Repeal & Saving. in force are hereby repealed.

> Provided that any order made or anything done or any action taken under the rules so repealed or under any general orders ancillary thereto, shall be deemed to have been done or taken under the corresponding provisions of these rules.
