#### NOTIFICATION

No.A. 12018/39/80-APT (B), the 6th October, 1994. In exercise of the powers conferred by the proviso to Article 309 of the constitution of India, the Governor of Mizoram is pleased to make the following rules relating to the recruitment to the posts of Assistant Director of Survey under Land Revenue and Settlement Department, Government of Mizoram namely:

- 1. Short title and (i) These rules may be called the Mizoram Land Revenue commencement: and Settlement Department (Group 'A' post) Recruitment Rules, 1994.
  - (ii) They shall come into force on the date of their publication in the Official Gazette.
- 2. Application:

The Rules shall apply to the post(s) specified in Col. 1 of the Annexure-I hereto annexed.

3. Number of posts, classification and scale of pay:

The number of the said post(s), their classification and the scale of pay attached thereto shall be as specified in col. 2 to 4 of the Annexure-I aforesaid.

4. Method of recruitment, age limit and other qualification

The age limit, qualification and other matters relating to the said posts, shall be as specified in columns 5 to 14 of the said Annexure-I.

Provided that the upper age limit prescribed for direct recruitment may be relaxed in the case of candidates belonging to the Scheduled Castes, Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Central Govt. or Govt. of Mizoram from time to time.

5. Disqualification.

No person,

a) Who has entered into or contracted a marriage with a person having a spouse living; or

b) who having a spouse living has entered into or contracted marriage with any person shall be eligible for appointment to the said post.

Provided that the Governor may, if sati fied that such marriage is permissible under the personal law applicable to such person and to other party to the marriage and that there are other grounds for doing so, exempt any person from the operation of this rules.

6. Training and Departmental Examination.

Every Govt, servant shall undergo such training or pass such Departmental Examination as may be prescribed from time to time.

7. Power to relax.

Where the Governor is of the opinion that it is necessary or expedient so to do, he may by order and for reasons to be recorded in writing relax any of the provisions of these Rules with respect to any class or category of persons.

8. Reservation and ether concessions.

Nothing in these rules shall effect reservation and other concessions required to be provided for the Scheduled Caste, the Scheduled Tribes and other categories of persons in accordance with the orders issued by the Central Govt. or Govt, of Mizoram from time to time in this regards.

9. Repeal & Saving.

The Land Revenue and Settlement Department Mizoram Group 'B' post R/R of 1985 in so far on its relates to the Recruitment Rules for Asstt. Survey Officers, notified under Govt. letter No. A 12018/39/80-AP i (B) dt 25. 6. 86 is hereby repealed;

Provided that any order made or anything done or any action taken under the rules so repealed or under any general orders ancillary thereto, shall be deemed to have been made, done or taken under the corresponding provisions of these rules.
