NOTIFICATION

NOTIFICATION UNDER SECTION 29 (2) OF THE ELECTRICITY (SUPPLY) ACT, 1948 AS AMENDED.

No.B.24032/1/93-P&E the 30th November, 1994. Whereas the Department of Power & Electricity Mizoram, Aizawl, a Government organisation has taken up the construction work of 7th Plan Transmission Scheme relating to the Establishment, Construction, Operation and Maintenance of Sub-Station and Transmission lines as given in detail below:—

Whereas under section 29 (2) of the said act, the Power & Electricity Department is required to publish the said schemes in the Official Gazette.

Now, therefore, the Department of Power & Electricity hereby publish the said scheme in compliance with the said section of Electricity Supply Act, 1948.

SCHEME : 7TH PLAN TRANSMISSION SCHEME

(A) TRANSMISSION LINES :

- a) 132KV Zemabawk to Khawzawl (87 Kms)
- b) 132KV Zemabawk to W. Phaileng (60 Kms)
- c) 132KV Lunglei to Lawngtlai (50 Kms)
- d) 132KV Serchhip to Lungdar 'E' (45 Kms)
- e) 132KV Serchhip to Marpara (100 Kms)
- f) 132KV Lunglei to Lungsens (40 Kms)

(B) SUB-STATION :

- a) 66KV W. Phaileng (2x2. 5MVA) (Departmental land available)
- b) 66KV Saitual (2x2. 5MVA) (Departmental land available)
- c) 66KV Khawzawl (2x2. 5MVA) (Departmental land available)
- d) 33KV Lungdar East (2x2. 5MVA) (Departmental land available)
- e) 33KV Marpara (2x2. 5MVA) (Departmental land available)
- f) 33KV Lungsens (2x2. 5MVA) (Departmental land available)
- g) 33KV Lawngtlai (2x2. 5MVA) (Departmental land available)

SALIENT FEATURES OF THE SCHEME :

The scope of the work includes erection of 132KV Single Circuit Transmission line at various places mentioned above with switchyard and sub-station referred above.

LOCATION : At various places above.

ESTIMATED COST : The estimated cost of 7th Plan Transmission Scheme is Rs. 4033.84 lakhs.

BENEFITS : The project will enable to transmit grid power to different parts of Mizoram, thus limiting use of costly Diesel Generating sets, improve availability of power for domestic and industrial consumers.

POWER FOR PLACING TRANSMISSION LINES, TOWRS ETC.

For placing Transmission lines, towers, wires, equipments and appliances for the transmission and distribution of Electricity or for Transmission of Telephone or telegraphic communication necessary for the purpose of undertaking, executing and operation of the scheme, the Department of Power & Electricity shall, in accordance with the provision of section 42 of Indian Electricity (Supply) Act, 1948 have and shall exercise all the powers which the telegraphic Act, 1985 with respect to telegraphic lines established or maintained.

Also notice is hereby given, inviting licences and other persons interested who are likely to be affected to make representations on the schemes to the undersigned within a period of 2 (two) months with effect from the date of its publication for consideration.
