NOTIFICATION

No. A. 12018/2/87-P&R(45), the 15th January, 1996. In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Mizoram is pleased to make the following rules relating to the recruitment to the posts indicated in the Annexure—I.

- 1. Short title and commencement.
- i) These Rules may be called the Mizoram G.A.D. (Group 'C' post) Recruitment Rules, 1996.
- : ii) They shall come into force on the date of their publica-
- 2. Application.

The Rules shall apply to the post specified in Col. I of the Annexure- I hereto annexed.

3. Number : of posts, classification and scale of pay.

The number of the said post (s) their classification and the scale of pay attached thereto shall be as specified in the Annexure-I aforesaid.

4. Method:
of recruitment, age limit
and other qualifications.

The age limit, qualifications and other matters relating to the said post, shall be as specified in the Annexure—I.

Provided that the upper age limit prescribed for direct recruitment may be relaxed in the case of candidates belonging to the Scheduled Castes, Scheduled Tribes and other special categories of persons by five years or in accordance with the orders issued by the Government of Mizoram from time to time.

5. Disqualification

No person,

- a) who has entered into or contracted a marriage with a person having a spouse living, or
- b) who, having a spouse living, has entered into or contracted marriage with any other person, shall be eligible for appointment to the said post.

Provided that the Governor of Moram may, if satisfied that such marriage is permiss a under the personnel law applicable to such person and to other party to the marriage and that there are other founds for doing so, exempt any person from the operation of this Rule.

6. Training and Departmental Examination:

Every Government servant shall very go such training or pass such Departmental Examination as may be prescribed from time to time.

- 6 (a) Notwithstanding anything contained in these Rules, the Governor of Mizoram in public induced, have the right and power to transfer any Officer or Ontolo, recruited in accordance with these Rules to the post/gords/service specified in Schedule/Annexure to these rules to the post or position which is equivalent in rank or gradu.
- 7. Power to relax:

Where the Governor is of the opinion that it in necessary or expedient so to do, it may, by come and for reasons to be recorded in writing in consultant a with the Selection Committee through the Department of Personnel & Administrative Reforms, relax any of the processors of these Rules with respect to any class or category persons.

8. Reservation other concessions:

Nothing in these rules shall affect reservation and other concessions required to be provided to the Scheduled Caste, the Scheduled Tribes and other provides of persons in accordance with the orders issued by the Central/State Government from time to time in this regards.

9. Repeal & Saving:

All Rules pertaining to these posts for add by the Governor of Assam or by the Government of Assam and were in force in the erstwhile Mizo District and additioued to be in existence in pursuance of Government of India, Ministry of Home Affairs Notification No. 14/21/71-14-14-16 (ii) date 21.1.1972 are hereby repealed.

Provided that any order made of anything done or any action taken under the rules so appealed or under any general orders ancillary thereto, shall be deemed to have been made, done or taken under the corresponding provisions of these rules.
