The Mizoram Appropriation (No. 2) Act, 1995.

Received the assent of the Governor of Mizoram on the 30th March, 1995.

AN ACT

THE MIZORAM APPROPRIATION (NO. 2) ACT, 1995 (As passed by the Legislative Assembly on the 29th March, 1995)

BE it enacted by the Legislative Assembly of Mizoram in the Forty-sixth Year of Republic of India as follows:

Short title

Issue of Rs 645,20,90,000.00 from and out of the Consolidated Fund of the State of Mizoram for the financial year 1995—96.

- 1. This Act may be called the Mizoram Appropriation (No. 2) Act, 1995.
- 2. From and out of the Consolidated Fund of the State of Mizoram, there may be paid and applied sums not exceeding those specified in Column 3 of Schedule amounting in the aggregate to the sum of six hundred forty five crores twenty lakhs ninety thousand rupees towards defraying the several charges which will come in course of payment during the financial year 1995—96, in respect of the services specified in column 2 of the Schedule.

### Appropriation

3. The sums authorised to be paid and applied from and out of the Consolidated Fund of the State of Mizoram by this Act shall be appropriate for the services and purposes expressed in the Schedule in relation to the said year.
