## NOTIFICATION

No. A. 12018/90/80-APT (B), the 16th August, 1995. In exercise of the powers conferred by the proviso to Article 309 of the Constitution, the Governor of Mizoram is pleased to make the following rules relating to the recruitment to the post of Assistant Drug Controller.

1. Short title : (i) These Rules may be called the Mizoram Health & Family Welfare Department Group 'A' (Gazetted) Recruitment Rules 1995.  
(ii) They shall come into force on the date of their publication in the Official Gazette.
2. Application. : The Rules shall apply to the post specified in Col. I of the Annexure-I hereto annexed.
3. Number of : The number of the said post(s), their classification and the posts, classification and scale of pay attached thereto shall be as specified in scale of pay. Col. 2 to 4 of the Annexure-I aforesaid.
4. Method of : The age limit, qualifications and other matters relating to the recruitment, age limit and other qualifications. said post, shall be as specified in Cols. 5 to 14 of the Annexure-I aforesaid.

Provided that the upper age limit prescribed for direct recruitment may be relaxed in the case of candidates belonging to the Scheduled Castes, Scheduled Tribes and other special categories of persons Central Govt. or in accordance with the orders issued by the Central Govt. or Government of Mizoram from time to time.

5. Disqualifica- : No person,  
tion. (a) who has entered into or contracted a marriage with a person having a spouse living, or  
(b) who, having a spouse living has entered into or contracted marriage with any persons, shall be eligible for appointment to the said post.

Provided that the Governor may if satisfied that such marriage is permissible under the personnel law applicable to such person and to other party to the marriage and that there are other ground for doing so, exempt any personal from the operation of this Rule.

6. Training and : Every Govt. servant shall undergo such training or pass  
Departmental such Departmental Examination as may be prescribed from  
Examination. time to time.

- (a) Notwithstanding anything contained in these Rules, the Governor of Mizoram in public interest have the right and power to transfer any Officer, recruited in accordance with these Rules to the post/posts/service specified in Schedule/Annexure to these rules to any other post or position which is equivalent in rank or grade.

7. Power to relax. : Where the Governor is of the opinion that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in writing in consultation with the selection committee through the Department of Personnel and Administrative Reforms, relax any of the provisions of these Rules with respect to any class or category of persons.

8. Reservation, : Nothing in these Rules shall affect reservation and other  
other conces- concessions required to be provided for the Scheduled Castes,  
sions. the Scheduled Tribes and other categories or persons in accordance with the orders issued by the Central/State Govt. from time to time in this regards.

9. Repeal & Saving. All Rules pertaining to these posts framed by the Governor of Assam or by the Govt. of Assam and were in force in the erstwhile Mizo District and continued to be in existence in pursuance of Govt. of India, Ministry of Home Affairs Notification No. 14/21/71-HMP(ii) dt. 21.1.72 are hereby repealed.

Provided that any order made or anything done or any action taken under the rules so repealed or under any general orders ancillary thereto shall be deemed to have been made done or taken under the corresponding provisions of these rules.
