NOTIFICATION

No. A. 12018/2/87-P&R(45), the 15th January, 1996. In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Mizoram is pleased to make the following rules relating to the recruitment to the posts indicated in the Annexure—I.

- 1. Short title and commencement.
- i) These Rules may be called the Mizoram G.A.D. (Group 'C' post) Recruitment Rules, 1996.
- ii) They shall come into force on the date of their publicationinthe Official Gazette.
- 2. Application.

The Rules shall apply to the post specified in Col. I of the Annexure- I hereto annexed.

3. Number of posts, classification and scale of pay.

The number of the said post (s) their classification and the scale of pay attached thereto shall be as specified in the Annexure-I aforesaid.

4. Method: of recruitment, age limit and other qualifications.

The age limit, qualifications and other matters relating to the said post, shall be as specified in the Annexure—I.

Provided that the upper age limit prescribed for direct recruitment may be relaxed in the case of candidates belonging to the Scheduled Castes, Scheduled Tribes and other special categories of persons by five years or in accordance with the orders issued by the Government of Mizoram from time to time.

5. Disqualification

No person,

:

- a) who has entered into or contracted a marriage with a person having a spouse living, or
- b) who, having a spouse living, has carried into or contracted marriage with any other persons, shall be eligible for appointment to the said post.

Provided that the Governor of Mazoram may, if satisfied that such marriage is permissible under the personnel law applicable to such person and to other party to the marriage and that there are other grounds for doing so, exempt any person from the operation of this Rule.

6. Training and Departmental Examination:

Every Government servant shall jurder go such training or pass such Departmental Examination as may be prescribed from time to time.

- 6 (a) Motwithstanding anything contained in these Rules, the Covernor of Mizoram in public interest, have the right and power to transfer any Officer or Official, recruited in according with these Rules to the post/posts, ervice specified in Schedule/Annexure to these rules to any other post or position which is equivalent in rank or grade.
- 7. Power to relax:

Where the Governor is of the opinion that it in necessary or expedient so to do, it may, by order and for reasons to be recorded in writing in consultation.

Committee through the Department of Promonnel & Administrative Reforms, relax any of the provisions of these Rules with respect to any class or category of persons.

8. Reservation other concessions:

Nothing in these rules shall affect reservation and other concessions required to be provided for the Scheduled Caste, the Scheduled Tribes and other categories of persons in accordance with the orders issued by the Central/State Government from time to time in this regards.

9. Repeal & Saving:

All Rules pertaining to these posts fram a by the Governor of Assam or by the Government of Assam and were in force in the crstwhile Mizo District and configured to be in existence in pursuance of Government of Inche, Ministry of Home Affairs Notification No. 14/21/71-HMF (ii) date 21.1.1972 are hereby repealed.

Provided that any order made or anything done or any action taken under the rules so repealed or under any general orders ancillary thereto, shall be domed to have been made, done or taken under the corresponding provisions of these rules.
