## NOTIFICATION

No. G. 27038/1/93-TAX/119, the 19th February, 1996. In exercise of the powers conferred by section 1 of the Assam Amusement and Betting Tax Act, 1939 (Assam Act VI of 1939) adapted in the State of Mizoram and all other powers enabling him in this behalf, the Governor of Mizoram is pleased to make the following rules further to amend the Assam Amusement and Betting Tax Rules, 1939 namely:—

Short title and commencement

- 1. (1) These Rules may be called the Assam Amusement and Betting Tax (Mizoram Amendment) Rules, 1996.
- (2) They shall come into force on and from the date of publication in the Mizoram Gazette.

Insertion of new rule

- 2. In the Assam Amusement and Betting Tax Rules, 1939, after rule 14, the following rule shall be inserted namely:—
  - "14 A. Payment of entertainment tax on Cable Tele ision —
    (1) Every proprietor of entertainment provided with the aid of antenna or Cable Television shall furnish to prescribed Officer of his area information in Form XIX giving full details of the name and type of entertainment, place and full address of the proprietor, number of connection holders, amount of monthly subscription fee paid by each holder, amount of installation or connection charges for each connection holder and particulars of his licence required for running such entertainment.

- (2) The total amount of tax payable shall be determined at the rate of tax prescribed under section 3C with reference to the amount of payment for admission received by the proprietor per connection per month. This amount of tax shall be paid by the proprietor in cash in the appropriate Government Treasury through Challan by several day of each month following the month to which the payment relates and produce proof of payment to the rescribed officer of his area by tenth day of the month alongwith the statement in Form XX.
- (3) Every proprietor shall maintain a register in Form XXI which shall be up-dated every month.
- (4) Every proprietor in the event of surrender of connection by the connection holder shall inform the prescribed officer in writing within thirty days of such surrender".
