No.A.12018/8/89-P&AR(GSW), the 13th May, 1996. In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Mizoram is pleased to make the following rules relating to the recruitment to the posts indicated in the Annexure-I.

1. Short title : i) These Rules may be called the Mizoram Education & Human Resources Deptt. (Group 'C' post SCERT) Recruitment Rules, 1996.
ii) They shall come into force on the date of their publication in the Official Gazette.
2. Application : The Rules shall apply to the post specified in Col. I of the Annexure - I hereto annexed.
3. Number : The number of the said post(s) their classification and the of posts, classification and scale of pay shall be as specified in the Annexure - I aforesaid.
4. Method of : The age limit qualifications and other matters relating to the recruitment, age limit and other qualification shall be as specified in the Annexure - I. Provided that the upper age limit prescribed for direct recruitment may be relaxed in the case of candidates belonging to the Scheduled Castes, Scheduled Tribes and other special categories of persons by five years or in accordance with the orders issued by the Government of Mizoram from time to time.

5. Disquali- : No person,
fication
- a) who has entered into or contracted a marriage with a person having a spouse living; or
 - b) who having a spouse living, has entered into or contracted marriage with any other persons, shall be eligible or appointment to the said post.

Provided that the Government of Mizoram may, if satisfied that such marriage is permissible under the personal law applicable to the marriage and that there are other grounds for doing so, exempt any person from the operation of this Rules.

6. **Training and Departmental Examination :** The person recruited under these Rules shall undergo such training or pass such Departmental Examination as may be prescribed from time to time.

7. Transfer and posting : Notwithstanding anything contained in these Rules, the Governor of Mizoram in public interest may transfer any Officer or Official, recruited in accordance with these Rules to the post/posts/service specified in the Annexure to these rules to any other post or position which is equivalent in the rank or grade.

8. Power to relax : Where the Governor of Mizoram is of the opinion that it is necessary or expedient so to do, he may, by order and for reasons to be recorded in writing, relax any of the provisions of these Rules with respect to any class or category of persons.

9. Reservation, other concessions : Nothing in these rules shall effect reservation and other concessions required to be provided for the Scheduled Caste, Scheduled Tribes and other categories of persons in accordance with the orders issued by the State Government from time to time in this regards.

10. **Repeal & Saving :** All the Rules pertaining to the recruitment to these posts still in force are hereby repealed.

Provided that any order made or anything done or any action taken under the rules so repealed or under any general orders ancillary thereto shall be deemed to have been done or taken under the corresponding provisions of these rules.
