## NOTIFICATION

No. K. 12011/1/92—Rev, the 14th October, 1996. Whereas by Government Notification No. K. 12011/1/92—REV Dt 16. 3. 94 published in the Official Gazette and two daily local newspapers, it was notified under section 4 of the land Acquisition Act, 1894(Central Act 1 of 1894) (hereinafter referred to as the 'Said Act') that the land specified in the schedule appended to the said Notification was likely to be needed for the public purpose namely Land Acquisition for construction of Dam Axis for Serlui 'B' Hydel Project.

And whereas the appropriate Government (hereinaster referred to as the 'Government of Mizoram') after considering the report made under Sub-Section(2) of the section 5(A) of the said Act needed for the public purpose specified above.

Now, therefore, the Government declares under section 6 of the said Act that the said land is required for the public purpose specified above.

Now, Government also appoints under Clause (c) of section 3 of the said Act the Collector Aizawl District to perform the functions or a Collector, Aizawl District for all proceedings hereinafter to be taken in respect of the said land and directs him under Section 7 of the said Act to take order for the acquisition of the said land.

The Collector shall thereupon cause the land to be measured and made a plan of the same under Section 8 of the said Act (if n) already done) as per Section 4 of the said Act, and dispose of all objection and claims after causing a public notice of not less than 15 days to the persons interested at convenien places on or near, the land to be taken, stating the Government intention of taking over the possession of the said land as per Section 9 of the said Act.

A plan of the said land can be inspected at the Office of the Collector Aizawl District, Aizawl till the fina award is made as provided under Section 11 of the said Act.
