### NOTIFICATION

No.L.11011/1/95—REV/66, the 7th November, 1996. Whereas the land specified below has been transferred to the Environment and Forest Department, Govt. of Mizoram for the purpose of Compensatory land/Afforestation in lieu of Reserved Forest diverted under the Forest (Conservation) Act, 1980 for Non-forestry purpose covering an area of 43.75 hectares to facilitate implementation of construction of Indo-Bangladesh Border Road. The land so transferred shall be 'Reserved Forest' as provided under section 2(4) of the Lushai Hills District (House Sites) Act, 1953, Section 3(a) of the Mizo District (Agricultural land) Act, 1963 and as assigned under Sub-paragraph 3 of the Sixth Schedule to the Constitution of India.

Now, therefore, this land is transferred to the Environment and Forest Department, Mizoram on 26.9.1996, in accordance with the provision of Section 8(a) of the Mizo District (Land & Revenue) Act, 1956.
