Lunglei/Saiha on cash payment of Rs. 5/- each or on payment of Rs, 10/- by M.O. or by uncrossed I.P.O. drawn in favour of the Secretary, Mizoram Public Service Commission.

Being a member of the Bar and having been practicing as an Advocate in any Court in India for a period not less than 3 yrs. as per the Certificate issued by the Principal District Court or the Bar Association.

6. Age limit

: For 2(a) 21-30 years. For 2(b) 25-35 years.

7. Reservation if any

: As per Govt. standing Order.

  - 5) A Certificate to Proof that the applicant had actually Passed Cl-VI standard in Mizo Vernacular.
  - 6) Original & Quadruplicate copies of Treasury Challan or Original IPO or Original Cash receipts as the case may be.
  - 7) S.T. Certificate.
  - b) For Members of the Bar; application Written in plain paper Fully stating the particulars of the applicant's address to the Secretary MPSC should be accompanied by the following documents.
  - 1) Degree (in law) Certificate.
  - 2) Character Certificate.
  - 3) HSLC/HSS Certificate.
  - 4) Citizenship Certificate.
  - 5) A Certificate to proof that the applicant had actually passed Cl-VI standard in Mizo Vernacular.

- 6) Certificate issued by the Principal District Court or the Bar Association to the effect that the applicant have been practicing as an Advocate in any Court in India for a period not less than 3 years.
- 7) S.T. Certificate.

Those already in Government Service should apply through proper Channel.

Canvassing directly or indirectly will disqualify the candidate.

Incomplete application will Summarily be rejected.
