# **NOTIFICATION**

No. CB/VII-8/97/23, the 09th April, 1997. In exercise of the power conferred by Section 115/117 of Motor Vehicle Act 1988 (Act 59 of 1988) and being authorised by the Govt. of Mizoram vide Notification No. D. 12021/10/965-TRP/150 dated 11.3.1997, I, Shri L. Hrangnawna, Superintendent of Police, Aizawl District, being satisfied that it is necessary in the interest of public safety and convenience, do hereby impose the following traffic restrictions in the areas mentioned below with effect from the dates mentioned against each:

### 1. PARKING OF TAXIS

- i) The area of the road Vaivakawn to Luangmual below Zotlang road junction about 25 metres on the western side is notified as Parking area for Taxis. The present Taxi Stand at Vaivakawn is, therefore, shifted to the new Taxi Stand below Zotlang road. The present Taxi Stand at Vaivakawn, therefore, is notified as No Parking area for Taxis. This order will come into force w.e f. 14th April 1997.
- ii) The present one Tonner Stand on Chanmari—Ramhlun road between Pu P.C. Lalsanga building and A&T building is notified as Taxi Stand. The present Taxi Stand at Chanmari is, therefore, shifted to this new Taxi Stand. The present Chanmari Taxi Stand is, therefore, notified as No Parking area for Taxi. This order will come into force w.e.f. Ist May '97.
- iii) The area in front of the State Transport Office and M.C. Apex Bank measuring about 20 metres is notified as Taxi Stand. The Taxi Stand at Treasury Square is, therefore, notified as No Parking Area and shifted to the new Taxi Parking area. This order will come into force w.e.f. Ist May 1997.

### 2. PARKING OF ONE TONNER

The area from A&T building to Pu Lalbiakthanga Pachuau building on Ramhlun-Chanmari road is notified as One tonner Parking area. The present One tonner parking area from Pu P.C. Lalsanga building to A&T building is, therefore, shifted to this new One tonner notified Stand. This order will come into force w.e.f. 1st May 1997.

# 3. ONE WAY

The road from Bazar Bungkawn to Vaivakawn via Dawrpui Vengthar is notified One Way. Entry of Light vehicles are allowed from Bazar Bungkawn Point towards Vaivakawn. However, no entry will be allowed from Vaivakawn towards Bazar Bungkawn on this road. This order will come into force w.e.f. 1st May 1997.

# 4. NO PARKING

Both sides of the main road from 1st A.R. Commandant's residence area to Salvation Temple point is notified as No Parking area for all vehicles w.e.f. 14th April 1997.

5. Light vehicles are allowed to ply both ways on the road from Salvation Temple point towards S.B.I. junction w.e.f. 14th April 1997.
