G.S.R. 268 (E).—In exercise of the powers conferred by sub-section (2) of section 24 of the High Court Judges (Conditions of Service) Act, 1954 (28 of 1954), the Central Government hereby makes the following rules further to amend the High Court Judges Travelling Allowance Rules, 1956, namely:—

- 1. (1) These rules may be called the High Court Judges Travelling allowance (Amendment) Rules, 1996.
 - (2) They shall come into force on the date of publication in the Official Gazette.
- 2. In the High Court Judges Travelling Allowance Rules, 1956 in rule 7-C, after clause (e), in the second provisio,
 - (i) for the words "under the above rules" the words, brackets and letters "under clause (a) and (b) of the above rules" shall be substituted;

(ii) for the words and letters "under rule 7-B" the words and letters "under rule 7-A" shall be substituted.
