NOTIFICATION

No.CB/VII-8/97/12, the 12th May, 1997. In exercise of the powers conferred by Section 117 of Motor Vehicles Act, 1988 (Act 59 of 1988) and being authorised by the Govt. of Mizoram vide Notification No.D.12021/10/965-TRP/150 dated 11.3.97, I, Shri L.Hrangnawna, Superintendent of Police, Aizawl District, after duly consulting of all concerned authorities being satisfied that it is necessary in the interest of public safety and convenience, do hereby declare the following undermentioned places as Stand for Vehicles used for Bazar Buses, Tourist Carriage Night Buses and Taxis. This order will supercede all orders issued earlier in this regard. This notification unless decide otherwise will come into force w.e.f 10th June 1997.

I. LINE/BAZAR BUSES STAND

(i) BAWNGKAWN TO SAIRANG ROAD : On the road side between Ngama & Sons Bulding to Trucker's Garrage measuring distance of approximately 150 metres. The area will be used for parking of Line/Bazar Buses entering Aizawl town area from Sairang and Silchar sides.

(ii) BAWNGKAWN TO RAMHLUN ROAD : The road side between Zangena Petrol Pump and SCERT office southern approach road measuring approximately 200 metres. The area will be used for parking of Line/ Bazar Buses commg from Darlawn/Champhai/Serchhip sides.

(iii) NGAIZEL : The road side between Town Bus terminal bulding and proposed Kulikawn market shed measuring approximately 200 metres. The area will be used for parking of Line/Bazar Buses coming from Sialsuk/Aibawk/Hlimen side.

II. TOURIST CARRIAGE NIGHT BUS

On Bawngkawn to Zemabawk road, the road side along National Highway-54 from Zokai Workshop, Bawngkawn on the southern side to Pu P.C.Laldinga Building on the northern side measuring approximately 300 metres.

III. SHIFTING OF TOWN BUS STOP

The present bus stop at Thuampui (Zemabawk) located at the side of BRTF Welcome Arc is shifted to the place near CMP duty post. The shifting of this bus stand is necessary to avoid a risk of injury, accident etc., as it is located at the narrowest point of the road.

IV. FIXING OF TAXI STAND

TAXI STAND AT THUAMPUI ZEMABAWK : The area along Aizawl-Lunglei National Highway from Lalthuama Workshop towards the south east and also opposite to the MES side office is hereby declared as Taxi Stand. The area cover about 100 metres.
