NOTIFICATION

No. A. 12018/3/81-API(B), the 7th May, 1997. In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Mizoram is pleased to make the following rules relating to the recruitment to the post of Physical Instructor and Security Officer under Social Welfare Department of Govt. of Mizoram namely —

- Short title 1. (1) These Rules may be called the Mizoram Social welfare and comDepartment, (Group 'C' posts) Recruitment Rules, 1997.

 mencement.
 - (2) They shall come into force on the date of their publication in the Official Gazette.
 - Application. 2. These Rules shall apply to the posts specified in column-I of the Schedule hereto annexed.
 - Number of 3. The number of the said posts, their classification and the scale of pay attached thereto shall be as specified in scheduled aforesaid.
 - Method of 4. The age limit, qualifications and other matters relating to the said posts, shall be as specified in columns 5 to 13 of the other qualifications and other matters relating to the said posts, shall be as specified in columns 5 to 13 of the other qualifications.

Provided that the upper age limit prescribed for direct recruitment may be relaxed in the case of candidates belonging to the Scheduled Castes, Scheduled Tribes and other special categories of person issued by the Government of Mizoram from time to time.

Disqualification 5. No person,

- (a) who has entered into or contracted a marriage with a person having the spouse living.
 - b) who, having a spouse living, has entered into or contracted marriage with any person, shall be eligible for appointment to the said posts.

Provided that the Governor of Mizoram may, if satisfied under the personal laws applicable to such person and the other party to the marriage and there are other grounds for so, exempt any person from the operation of this Rule.

Training 6. and Deputation.

Every Government servant shall undergo such training or pass such Departmental Examination as may be prescribed from time to time.

Power to 7. transfer etc.

Notwithstanding anything contained in these Rules, the Government of Mizoram shall in public interest have the right and power to transfer any officer recruited under these Rules to the posts specified in the Schedule to these Rules, to any other post or position which is equivalent in rank or grade.

Power to 8. relax

Where the Governor is of the opinion that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in writing, in consultation with the Departmental Promotion Committee concerned and with prior concurrence of the DP&AR, Law & Judicial Department and Finance Department, may relax any of the provisions of these Rules in respect of any class or category of persons.

Reservation, 9. other concessions.

Nothing in these rules shall affect reservations, other concessions required to be provided for the Scheduled Castes, Scheduled Tribes and other categories of persons in accordance with the orders issued by the Central Government or Government of Mizoram from time to time in this regard.

Repeal and 10. Saving.

All the Rules pertaining to these posts framed by the Governor of Assam or by the Government of Assam and were in force in the erstwhile Mizo District and continued to be existence in pursuance of the Government of India, Ministry of Home Affairs' Notification No. 14/21/71-HMT(ii) dated 21.1.72 or framed by the Government of Mizoram prior to the commencement of these Rules, are hereby repealed.

Provided that any order made or anything done or any action taken under the Rules so repealed or under any general orders ancillary thereto shall be deemed to have been made, done or taken under the corresponding provisions of these Rules.
