NOTIFICATION

No. CB/VII-8/97/32, the 20th June, 1997. In exercise of the power conferred by Section 117 of Motor Vehicles Act 1988 (Act 59 of 1988) and under the authorisation given by the Government of Mizoram vide Notification No.D. 12021/10/965-TRP/15 dated 11.3.97, I, Shri L. Hrangnawna, Superintendent of Police, Aizawl District, after duly consulting of all concerned authorities being satisfied, found it necessary to notify the Parking Stations/Stands for the following Vehicles :—

- (1) Heavy Goods Carrying Vehicles (TMB Trucks).
- (2) Heavy Goods Carrying Vehicles (used as Town Tripper)
- (3) One Tonner Town Tripper (Medium Vehicles used as Town Tripper).

Therefore, in the interest of public safety and convenience, the following undermentioned Stations/Stands are notified for parking of the above given Goods Carrying Vehicles. This order will supercede all orders issued earlier in this regard. This order will come into force with effect from 17th July, 1997.

I. HEAVY GOODS CARRYING VEHICLES (TRUCKS) STATIONS/STANDS.

(1) All Heavy Goods Carrying Vehicles (Trucks) except the vehicles exempted by Government order coming from Silchar side via Sairang and via Durtlang to Aizawl will be parked on Bawngkawn - Sairang road starting from the Stone Quarry area (beyond the Parking place of Heavy Town Tripper Trucks) towards Vaivakawn road junction upto Pu Khualluna's building, Company peng. This area will be able to provide parking place for more than 150 Vehicles.

(2) All Heavy Goods Carrying Vehicles (Trucks), except the Vehicles exempted by Government order, coming from Seling to Aizawl will be parked on Zemabawk road in BRTF area starting from the Kendriya Vidyalaya approach road junction to Pu Bialzauva's building towards Zemabawk. This area will be able to provide parking place for atleast 75 Trucks.

(3) All Heavy Goods Carrying Vehicles (Trucks), except the Vehicles exempted by Government order, coming from Sialsuk and Aibawk towards Aizawl will be parked at Ngaizel from the area where a Sign Board is erected and written "God is Jesus Home" towards Saikhamakawn. This area will be able to provide parking place for atleast 75 Trucks.

II. HEAVY GOODS CARRYING VEHICLES (USED AS TOWN TRIPPER) STATIONS/STANDS.

From Pu Valbuanga's building to the second electric post just before the stone quarry measuring about 400fts. on Bawngkawn Sairang road.

III. ONE TONNER TOWN TRIPPER (MEDIUM VEHICLES USED AS TOWN TRIPPER) STANDS/STATIONS.

On Chandmari - Ramhlun road from Pu Ngurthanga's building to opposite to Pu V. Neihkunga's building measuring about 100 metres be used for parking of One Tonner Town Tripper.

The security and safety of the above vehicles at the places of parking will be the responsibility of the owners and drivers.
