#### NOTIFICATION

No. G. 31016/5/97-EXC/2 : the 19th June, 1997. In exercise of the powers conferred by the provisions to section 59 of the Mizoram Liquor Total Prohibition Act, 1995, also read with sub-rules (1), (3) and (4) of the Mizoram Liquor Total Prohibition Rules, 1996 and sub-rule (2) of Rule 16 of the Mizoram Liquor Total Prohibition (Amendment) Rules, 1997, the Governor of Mizoram is pleased to constitute District Prohibition Committees at the District Level for Aizawl and Lunglei Districts respectively consisting of the following Officials and non-Official residents of the District concerned with immediate effect and for a term of 2 (two) years at the first instance which may be extended for any longer period as deemed necessary by the Government.
