NOTIFICATION

NO.C. 31016/5/97-EXC/1 : the 19th June, 1997. In exercise of the powers conferred by sub-section (1) and (3) of section 59 of the Mizoram Liquor Total Prohibition Act, 1995, also read with sub-rules (1) and (4) of Rule 16 of the Mizoram Liquor Total Prohibition Rules, 1996 and sub-rule (2) of Rule 16 of the Mizoram Liquor Total Prohibition (Amendment) Rules, 1997, the Governor of Mizoram is pleased to constitute a State Prohibition Council at the State Level for Mizoram consisting of the following Officials and non-Official residents of the State of Mizoram with immediate effect and for a term of 2 (two) years at the first instance which may be extended for any longer period as deemed necessary by the State Government.
