NOTIFICATION

* No.A.12018/3/89-LJE, the 18th August, 1997. Whereas the cadre-strength of Mizoram Judicial Service was prescribed in Schedule 'A' to the Mizoram Judicial Service Rules, 1989 notified by the Government of Mizoram after prior consultation with the Hon'ble Gauhati High Court, under the Notification No. A. 12018/3/86 L & J. dated 11.9.1989 and published in the Mizoram dated Gazette Vol. XVIII, Extra Ordinary Issue No-72 dated 11.9.1989, pages 1-15;

Whereas the Mizoram Judicial Service Rules, 1989 was implemented with prior approval of DP & AR (C), dt 5.4.91 and 20.5.1991, of the Finance Department vide their U.O. No. FIN(A) 102/90 read with other communications subsequent thereto, and with approval of the Council of Ministers Vide Political and Cabinet Department's communication No.J.11012/2/91-POL, dated 11.9.1991;

Whereas operation of the Mizoram Judicial Service (First Amendment) Rules, 1993 notified by the Government of Mizoram in the Department of Personnel and Administrative Reforms under their No.A.12018/6/85-P&AR(GSW), dt 10.12.1993 and published in the Mizoram Gazette, Extra-Ordinary Issue No. 263, dated 21.12.1993 was suspended with effect from 7.1.1997 by the Government of Mizoram under their Notification No.A.12018/6/85-P&AR (GSW), dated 7. 1. 1997;

Whereas it is considered expedient to issue formal creation-orders of the cadre-posts of the Mizoram Judicial Service with the changes in designations and scales of pay in conformity with rules 4, 5, 13 and 23 read with schedule 'A' to the Mizoram Judicial Service Rules, 1989 and in consonance with the Gauhati High Court's approval.

Now, therefore, the Governor of Mizoram is pleased to order that the following cadre-posts of Mizoram Judicial Service shall be deemed to have been created with effect from 11. 9. 1989 i.e. the date of notification of the Mizoram Judicial Service Rules, 1989 in the Official Gazette ;

It is further conditioned that for the purposes of filling-up of any of the vacant posts concurrence of the Finance Department and the Council of Ministers would be required as per the existing decision of the Government.

This issues with the approval of the Council of Ministers conveyed under the Political and Cabinet Department's Memo. No. J. 11012/2,97-POL/Part, dated 29th July, 1957.
