NOTIFICATION

No.A. 12018/16/80—APT(B)/Vol-I: the 21st August, 1997. In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Mizoram is pleased to make the following rules relating to the recruitment to the post of Skilled Worker (Cane & Bamboo) Govt. of Mizoram, namely—

- 1. Short title and commencement.:
- i) These Rules may be called the Mizoram Industries Department (HHW) Group 'D' posts (Non-Gazetted)Recruitment Rules, 1997.
- ii) They shall come into force on the date of their publication in the Official Gazette.
- 2. Application:

The Rules shall apply to the post (s) specified in Col. I of the Schedule hereto annexed.

3. Number of posts, classification and scale of pay:

The number of the said post(s), their classification and the scale of pay attached thereto shall be as specified in Columns 2 to 4 of the Schedule aforesaid.

4. Method of rectt., age limit and other qualification:

The age limit, qualifications and other matters relating to the said post, shall be as specified in Columns 5 to 13 of the said Scheduled.

Provided that the upper age limit prescribed for direct recruitment may be relaxed in the case of candidates helonging to the Scheduled Castes, Scheduled Tribes and other special categories of persons by five years or in accordance with the orders issued by the Government of Mizoram from time to time.

Disqualification.

- 5. No person.
- a) who has entered into or contracted a marriage with person having a spouse living: OR
- who, having a spouse living has entered into or contracted a marriage with any person shall be eligible for appointment to the said post.

Provided that the Governor may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

6. Training and Departmental Examination.

Every Govt. servant recruited under these Rules shall undergo such training or pass such Department Examination as may be prescribed from time to time.

7. Power to transfer.

Notwithstanding anything contained in these Rules, the Government of Mizoram shall, in public interest, have the right and power to transfer any Officer so recruised under these Rules to any other post or position which is equivalent in rank or grade.

8. Reservation, other concessions.

Where the Governor is of the opinion that it is necessary or expedient so to do, it may by order and for reasons to be recorded in writing, in consultation with the Selection Committee/Departmental Promotion Committee through the Department of Personnel and Administrative Reforms, relax any of the provisions of these Rules with respect to any class or category of persons.

9. Repeal and Savings.

Nothing in these Rules shall affect concessions required to be provided for the Scheduled Castes, the Scheduled Tribes and other categories of persons in accordance with the orders issued by the Central Govt. or Govt. of Mizoram from time to time in this regards.

10. Repeal Savings.

All Rules pertaining to these posts framed by the Governor of Assam or by the Govt. of Assam and were in force in the erstwhile Mizo District and continued to be in existence in pursuance of Govt. of India, Ministry of Home Affairs Notification No. 14/21/71-HMP(ii) dated 21.1.1972 are hereby repealed.

Provided that any order made or anything done or any action taken under the rules so repealed or under any general orders ancillary thereto, shall be deemed to have been made, done or taken under the corresponding provisions of these rules.
