NOTIFICATION

No.F. 13015/1/97-LAC/65 the 11th September, 1997. Whereas the Central Government has notified the 22nd day of August, 1997 as the date on which the provisions of the Chapter-III of the Legal Services Authorities Act, 1987 (Act No. 39 of 1987) as amended from time to time, shall come into force in the State of Mizoram, under their notification No.F.6(1) (16)/95-NALSA, dt. 26.8.1997.

And, whereas the Hon'ble Chief Justice (Acting), Gauhati High Court had approved the constitution of the State Legal Services Authority and two District Legal Services Authorities (i.e. Aizawl & Lunglei), vide No.HC-VII-15/96/3275/RC, dated 9.6.1997.

Now, in exercise of the powers conferred under section 6(1) of the Legal Services Authorities Act, 1987 as amended from time to time, read with Rule 3 of the Mizoram State Legal Services Authorities Rules, 1996 as amended from time to time, the Governor of Mizoram is pleased to constitute the Mizoram State Legal Services Authority, with the following compositions, with immediate effect :—
