The Aizawl East District Leprosy Society constituted should be registered under the Societies Registration Act, immediately.

- (a) Society will directly be responsible to oversee the implementation of the programme in the District.
- (b) Society will be fully responsible for rendering accounts to the Ministry of Health & Family Welfare, Government of India for t e grant-in aid to be released by the Ministry from time to time. Society should ensure its functioning with immedia e effect. The Society will be responsible to frame Rules and Regulations of its own in accordance with the guide lines of the Ministry of Health & Family Welfare Government of India issued from time to

## MEMORANDUM OF ASSOCIATION THE A!ZAWL EAST DISTRICT LEPROSY SOCIETY

- 1. Name : The name of Society shall be Aizawl East District Leprosy Society
- 2. Registered: The registered office of the Society shall be at DCM&HO's Office, Aizawl Fast or such other place as may from time to time determinated by the Executive Body.
- 3. Area of : Entire Aizawl East District.
  Operation
- 4 Aims & : The aims and objectives shall be :— Object.
  - 1. To eradicate Leprosy by 2000 AD by bringing all leprosy cases under treatment known as Multi-Drug Therapy in the District.
  - 2. To ensure early detection and cure of the disease, and to prevent relapses and physical deformity.
  - 3. To render all infections cases to non-infections; so as to interrupt the chain of transmission in the community.
  - 4. To prevent development of resistance or killing of resistant germs in leprosy patients for an infectious leprosy eradication programme.
  - 5. To carry out systematic Health Education activities with a view to disseminate important facts about leprosy and to remove Social stigma and make available modern therapy for leprosy.
  - 6. To emphasise the need for rehabilitation and Welfare of cured patients in the district.
  - 7. To accept donations or general purpose, conductive to the benefit of the Aizawl East District Leprosy Society and to carry out the endowment to the promotion or carrying out of the objects of the Society.
  - 8. Generally to do all things as are incidental and conductive to the promotion or carrying out of the objects of the Society.
