#### **NOTIFICATION**

#### **CERTIFICATE OF REGISTRATION OF AMENDMENT OF BYE-LAWS OF MIZOFED (RULE 10(3))**

In the office of the Registrar of Cooperative Societies under the Mizoram Cooperative Societies Act 1991. (Act 19 of 1991).

I do hereby certify that pursuance to the Mizoram Cooperative Societies Act, 1991 (Act 19 of 1991), the amendments shown in the enclosed document of the Bye-Laws of the Mizoram State Cooperative Marketing & Consumers' Federation Limited, a Cooperative Society registered under the aforesaid Act on the Ninth day of December 1981 under No.A-153/81-82 in the District of Aizawl has been duly registered. The following is the area of operation of the Society : the whole of Mizoram.

The Bye-Laws amended and registered this day are as follows :—

No. of Bye-Laws

Proposed Provision as will  
stand amended

1. Bye-Law No. 27

“Except by an order of the R.C.S., no resolution can be brought at a General Meeting for cancelling a previous resolution of the General body unless six clear months have elapsed after the passing of original resolution”.

2. Bye-Law No. 29(2)

“Notwithstanding anything contained in this Bye-Laws, the first Board of Directors of the MIZOFED Ltd. Aizawl, shall be nominated by the Govt. of Mizoram and shall hold office untill such time as the Govt. permits holding of the General Assembly, until then the first Board of Directors shall have full powers of the General Assembly”.

## 3. Bye-Law No. 31

“The Chairman shall be elected by members present in General Meeting. When present, the Chairman shall preside over all the Meetings of the Board. In his absence, the members present shall elect one from among themselves as the Chairman of the Meeting. The Chairman is entitled to give a casting vote in addition to his ordinary vote in case of equality of votes”.

## 4. Bye-Law No.14(b)(5)

“To be in over all charges of the Management of the Federation subject to the appropriate approval of the Registrar, Cooperative Societies, the Board of Directors/Government”.

**The above amended By-Laws.**

effect. Amended Bye Law No. 31 shall have effect on the expiry of the Third Mizoram Legislative Assembly or on the date the present Chairman cease to be a member of the present Assembly, or the date he cease to be the Chairman of this Federation, whichever is earlier. This Amendment cancels any approval given earlier which is violative of the amended Bye-Laws of the Federations.
