## NOTIFICATION

No. A.12018/7/85-P&AR(GSW)/, the 7th November, 1997. In exercise of the powers conferred by the Proviso to Article 309 of the Constitution of India, the Governor of Mizoram is pleased to make the following Rules relating to the recruitment to the posts of Personal Assistant to Governor, Mizoram namely :-

- 1. Short title (1) These Rules may be called the Mizoram Governor's Secretaand commencement. (1) These Rules may be called the Mizoram Governor's Secretariat (Group 'A' post) Recruitment Rules, 1997.
  - (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. Application. These Rules shall apply to the posts specified in column 1 of Ann xupe to these rules.
- 3. Number of posts, The number of the said post (s), their classification and the classification & scale of pay attached thereto shall be as specified in Scale of pay. columns 2 to 4 of the Annexure aforesaid.
- 4. Method of The age limit, qualifications and other matters relating to Rectt., age the said post, shall be as specified in columns 5 to 14 of limit and other the said Annexure. qualifications.
- 5. Disquali- No person, fication.

- (a) who has entered into or contracted a marriage with a person having a spouse living; OR
  - b) who, having a spouse living has entered into or contracted a marriage with any person shall be eligible for appointment to the said post.

Provided that the Governor may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for doing so, exempt any person from the operation of this Rule.

- 6. Training and Departmental Examination. Every Govt. servant recruited under these Rules shall undergo such training or pass such Departmental Examinations as may be prescribed from time to time.
- 7. Power to transfer. Notwithstanding anything contained in these Rules, the Govt. of Mizoram shall, in public interest, have the right and power to transfer any Officers so recruited under these Rules to any other post or position which is equivalent in rank or grade.
- 8. Power to relax. Where the Governor is of the opinion that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in writing in consultation with Selection Committee/Departmental Promotion Committee through the Department of Personnel & Admn. Reforms, relax any of the provisions of these Rules with respect to any class or category of persons.
- 9. Reservation, other concessions. Nothing in these Rules shall affect reservation and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes and other categories of persons in accordance with the orders issued by the Central Govt. or Govt. of Mizoram from time to time in this regard.
- 10. Repeal and Saving. All Rules pertaining to these posts framed by the Governor of Mizoram or by the Govt. of Mizoram under the Notification No. A. 12018/48/80-APT (B) dated 19.8.1987 published in the Mizoram Gazette Issue No. 87 dated 19.8.1987 and were in force in the State of Mizoram and continued to be in existance in pursuance of the said Notification till date, stand either repealed or accordingly modified, as the case may be.

Provided that any order made or anything done or any action taken under the Rules so repealed or under any general orders ancillary thereto, shall be deemed to have been made, done or taken under the corresponding provisions of these Rules.
