NOTIFICATION

CERTIFICATE OF REGISTRATION OF AMENDMENT OF BYE-LAWS (RULE 10 (3))

In the office of the Registrar of Co-operative Societies, under the Mizoram Co-operative Societies Act, 1991 (Act 19 of 1991).

I do hereby certify that pursuant to the Mizoram Co-operative Societies Act, 1991 (Act 19 of 1991), the amendments shown in the enclosed document of the Bye-Laws of the Mizoram State Cooperative Fruit Forestry and Vegetable Federation (MAFF) Limited, a Cooperative Society registered under the aforesaid Act on the Fifth day of June 1984 under No.A-31/83-84 in the District of Aizawl has been duly registered. The following is the area of operation of the Society :

“The whole of Mizoram”

The Bye-Laws amended and registered this day are as follows :-

1. Bye-Laws No.5.

The membership shall be opened to Primary Fruits & Vegetable Marketing Societies, Farming Cooperative Societies, LAMPS, Area Farming Cooperative Federation, District Co-operative Banks, State Cooperative Agricultural Development Bank, National Cooperative Development Cooperation, National Dairy Development Board, PACS including Service Cooperative Societies, Primary Agril. Credit Coop. Societies etc. and any other Cooperative Societies which undertake in the production of Fruits, Vegetables, Forest produces State and Central Government. The liability of members shall be limited to the share capital subscribed by them.

2. BYE-LAW NO. 6 (iii) "The quorum of a meeting of the General Assembly shall be one-fifth of the total number of members existing as such on the date of issue of the notice of the meeting or one hundred whichever is less. The Board of Director may at any time calls General Body Meeting or shall call such meeting within 1 month on receipt of acquisition in writing from two-third of the affiliated Societies, thirty days notice shall be given for the meeting".
3. BYE - LAW NO. 7 (i) (a) "Nine members from among the elected members of the management of the Affiliated Cooperative Societies. Only one nomination can be made from each Society".
4. BYE-LAW NO. 7 (i) (b) to (e) Besides mentioning at Bye Law No. 7 (i) (b) to (e) the followings are included in the Board of Directors -
- 1) Development Officer, N.C.D.C.
 - 2) Director, Agriculture, Government of Mizoram.
 - 3) Managing Director, MIFCO.
5. BYE-LAW NO. 7 (iv) The General Assembly shall directly elect a Chairman, Vice Chairman and seven other Board of Directors from among the affiliated Societies.

These amended Bye-Laws will take immediate effect.
