

## NOTIFICATION

No.K.15011/8/94-REV/Pt, the 16th February, 1998. Whereas it appears to the Appropriate Government (hereinafter referred to as Government of Mizoram) that the land specified in the scheduled thereto, (hereinafter referred to as the "said land") is likely to be needed for public purpose viz. Acquisition of land at Zemabawk for approach road to Regional Para Medical & Nurses Training. Institution.

Now, therefore, the Government hereby notifies, under sub-section (i) of section 4 of the Land Acquisition Act, 1894 (Central Act 1 of 1894) hereinafter referred to as the said Act) that the said land is likely to be needed for the purpose specified above.

- 2. Any person interested in any land being notified may submit their objection to the acquisition in writing to Pu Hrangtawna ASO-I within a period of 30 days from the date of publication of this Notification in the Mizoram Gazette, who will dispose of the objection and claims as per provision of Section 5-A of the Land Acquisition Act 1894.
- 3. All persons interested in the said land are hereby warned not to obstruct or in erfere with any surveyor or other persons employed upon the said land for the purpose of the said acquisition. Any contract for the disposal of the said land by sale, lease, mortgage, assignment, exchange of the status of Pass or otherwise or any outlay commenced for improvements made therein without the sanction of the Asstt. Settlement Officer-I, will under clause (Seventh) of Section 24 of the said Act, be disregarded while assessing compensation for sucu parts of the said land as may be finally acquired.
- 4. If the Government satisfied that the land needed for the aforesaid purpose, a declaration to the effect that under section 6 of the said Act will be published in the Official Gazette and the two daily newspapers and public notice thereof shall be given in due course. If the acquisition is abandoned wholly or in part, the fact will also be notified in the same manner.

5. The Government further appoints under clause (C) of section 3 of the said Act. Pu Hrangtawna ASO-I to perform the functions of the Collector under the said Act in respect of the said land.
