NOTIFICATION

No. K. 15011/66/95-REV, the 15th April, 1998. Whereas by Government Notification K. 15011/6/95-REV dt. 13th Oct, 1997 published in the Official Gazette and two daily newspapers, it was notified under section 4 of the Land Acquisition Act, 1894 (Central Act 1 of 1894) (bereinafter referred to as the "said Act") that the land specified in the schedule appended to the said Notification was likely to be needed for the purpose namely Acquisition of land at Zokhawthar for Establishment of INDO-MYANMAR BORDER TRADE.

And whereas the appropriate Government (hereinaster referred to as the "Government of Mizoram") after considering the report made under sub-section (2) of the section 5 (A) of the said Act needed for the purpose specified above

Now, therefore, the Government declares under section 6 of the said Act that the said land is required for the public purpose specified above.

The Government also appoints, under clause (C) of section 8 of the said Act that Deputy Commissioner Aizawl to perform the functions of a Collector for all proceedings hereinafter to be taken in respect of the said land and directs him under section 7 of the said Act to take order for the acquisition of the said land.

The Collector shall thereupon cause the land to be measured and make a plan of the same under Section 8 of the said Act if not already done as per section 4 of the said Act, and dispose of all objections and claims after causing a public notice of not less than 15 days to the persons interested at convenient places on or near the land to be taken, stating the Government intention of taking over the possession of the said land as per section 9 of the said Act. Then, the Collector shall submit a Draft Award to the Govt. of Mizoram after fulfilling the provisions under section 11 of the said Act.

A plan of the said can be inspected at the Office of the Deputy Commissioner Aizawl till the final award is made under section 11 of the said Act.
