#### NOTIFICATION

No. A.12018/12/80-APT(B)/, the 23rd April, 1998. In exercise of the powers conferred by the Proviso to Article 309 of the Constitution of India, the Governor of Mizoram is pleased to make the following Rules relating to the recruitment to the posts of Assistant Town & Country Planner under Local Administration (Town & Country Planning Wing) Department, Govt. of Mizoram namely:

- 1. Short title (i) These Rules may be called the Mizoram Local Administration in Town & Country Planning Department (Group 'A' post) Recruitmen Rules, 1993.
  - (ii) They shall come into force on the date of their publication in the Official Gazette.
- 2. Application. The Rules shall apply to the post specified in column 1 of Annexure-I hereto annexed.
- 3. Number of posts, The number of the said post (s), their classification and the classification & scale of pay attached thereto shall be as specified in Scale of pay. columns 2 to 4 of the Annexure-I aforesaid.
- 4. Method of Rectt., age limit and other qualifications.

The age limit, qualifications and other matters relating to the said post, shall be as specified in columns 5 to 14 of the said Annexure-I.

Provided that the age limit, prescribed for direct recruitment may be relaxed in the case of candidates belonging to the Scheduled Caste, Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Central Govt. or Govt. of Mizoram from time to time.

·5. Disqualification.

No person.

(a) who has entered into or contracted a marriage with a person having a spouse living; OR

b) who, having a spouse living has entered into or contracted a marriage with any person shall be eligible for appointment to the said post.

Provided that the Governor may, if satisfied that such marriage is permissible under the personal law applicable to such person and to other party to the marriage and that there are other grounds for doing so, exempt any person from the operation of these Rule.

6. Training and Departmental Examination.

Every Govt. servant recruited under these Rules shall undergo such training or pass such Departmental Examinations as may be prescribed from time to time.

7. Power to transfer.

Notwithstanding anything contained in these Rules, the Government of Mizoram in public interest, has the right and power to transfer any Officers so recruited under these Rules to any other post or position which is equivalent in rank or grade.

8. Power to relax.

Where the Governor is of the opinion that it is necessary or expedient so to do, it may by order and for reasons to be recorded in writing in consultation with the Selection Committee/Departmental Promotion Committee through the Department of Personnel & Admn. Reforms, relax any of the provisions of these rules with respect to any class or category of persons.

9. Reservation, other concessions.

Nothing in these Rules shall affect reservation and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes and other categories of persons in accordance with the orders issued by the Central Govt. or Govt. of Mizoram from time to time in this regard.

10. Repeal and Saving.

All Rules pertaining to these posts framed by the Government of Mizoram or Governor of Mizoram and continued to be in existence in pursuance of Govt. of India, Ministry of Home Affairs Notification No. 14/21/71-HMP (ii) dated 21.1.1972 and No. A. 12018/14(ii)/82-APP(B) dated 8.6.1987 and No. A. 12018/87/80-APT(B) dated 22.5.1989 are hereby repleased.

Provided that any order made or anything done or any action taken under the Rules so repealed or under any general orders ancillary thereto, shall be deemed to have been made, done or taken under the corresponding provisions of these rules.
