NOTICE IS HEREBY GIVEN THAT —

- 1. The Election is to be held to elect 15 (fifteen) Members to the Bar Council of Assam, Nagaland, Meghalaya, Manipur, Tripura, Mizoram and Arunachal Pradesh; out of which 8 (eight) Members are to be elected from amongst the Advocates whose names have been on the State Roll for at least 10 years.
- 2. Forms of Nomination Paper may be obtained from the Office of the Council as well as from the Offices of all Bir Associations of Assam, Nagaland, Meghalaya, Manipur, Tripura, Mizoram and Arunachal Pradesh.
- 3. The Nomination Papers addressed to the Secretary proposed by 1 (one) Voter and seconded by another Voter (Vide Rule 8 of the Bar Council Election Rules, 1968) may be delivered to the Secretary in the office of the Council during the office hours (FROM 10 A.M. to 4 P.M.) on any date not later than the 21st August, 1998. Nomination paper for a candidate must be accompanied by a fee of Rs. 200/- (Rupees Two hundred) and The Nomination Fee is to be paid either by a Bank Draft of any nationalised Bank having branch at Guwahati or by Cash in the office of the Council.

- 4. The Nomination papers will be taken up for scrutiny at 11 A.M. on 22nd August, 1998.
- 5. The Notice of withdrawal of the candidature by a candidate may be delivered to the Secretary before 4 P.M. on 29th August, 1998.
- 6. In the event of the election being contested, the poll will take place on Tuesday the 22nd September, 1998 between the hours of 10 A.M. to 4 P.M. and voting by personal ballot will be held at Guwahati, Nalbari, Barpeta, Dhubri Kokrajhar Goalpara, Bongaigaon. Shillong, Tezpur, Mangaldoi, Nagaon, Sankardevnagar (Hojai), Golaghat, Sibsagar, Dibrugarh, Tinsukia, Imphal. Dimapur, Silchar, Karimganj, Hailakandi, Aizawl, Agartala, Dharmanagar, Kairasahar and Kamalpur. At Guwahati the election will be held at the premises of the High Court Bar Association and in Imphal at the premises of All Manipur Bar Association and in rest of the centres election will be held at the respective Bar Association premises. The Voters of the rest of the places of Assam, Nagaland, Meghalaya, Manipur, Tripura, Mizoram and Arunachal Pradesh will vote by post.
- 7. The Voting papers despatched by post must reach the Secretary not later than the 25th September, 1998.
- -8. The Counting of Votes will begin at 11 A.M. on 23rd October, 1998.
