

TERMS OF REFERENCE

- 1) To inquire into the alleged irregularities in the selection of candidates for MBBS Course with particular reference to the points raised by the MZP in their Circular No. I of 1998 dt. 8.8.98.
- 2) To fix responsibility for irregularities, if any, in the selection process, and
- 3) To suggest remedial measures and recommend steps to be taken to avoid such problems in future.

The Commission shall submit its report to the Government within 10 days from the date of issue of its constitution.

2. Interview naah hian an uluk loin mimal in duhsakna a awm niin alang
 a. Pa hm^{ing} leh Telephone Number chauh zawhte an awm a, dik veka an chhan pawhin Mark an hmu tha chuang lo. Tin, thlante zingah hian India chhim lam chhuak Mark 5 aia sang hmu an awm miah lo bawk.

3. Higher & Technical Education Director chuan result a staff thenkhatte nen ama mimal In ah an buai puiin an siam chhuak.

4. Thlanchhuahte result hi a hun hmain a put ru (Leakout) ngei a ani.

5. MBBS zir tura thlan zingah hian Marksheets lem hmang an awm ngei ani tih hriat a ni. Class XII passed lo si thlan zingah hian an awm ngei a hriat a ni.

6. Thlanchhuahte list hi puanzar vek a anih tawh hnuah siam danglama a thar siam leh a ni.

7. Heta thlan chhuahte zinga mite pawhin duhthlanna (Preferential Choice) an nei thei chuang lo.
