## NOTIFICATION

No.A. 60011/21/95-GAD, the 24th September, 1998. As a corollary to the recent creation of new Districts and in continuation of this Department's Notification of even No. dt. 26.8.98, the Governor of Mizoram is pleased to create the following new Sub-Divisions:

- 1. VAIRENGTE CIVIL SUB-DIVISION IN AIZAWL 'N' DISTRICT: This new Civil Sub-Division shall comprise the areas covered by Bilkhawthlir Assembly Constituency excluding the two Villages of Saiptim and Saiphai which are within the notified area of the Sinlung Hills Development Council. The Headquarters of this new Civil Sub-Division will be located at Vairengte.
- 2. KAWNPUI CIVIL SUB-DIVISION IN AIZAWL 'N' DISTRICT: This new Civil Sub-Division shall comprise the areas covered by Kawnpui Assembly Constituency excluding Thingdawl town which will form part of the new District Headquarters of Kolasib. The Headquarters of this new Civil Sub-Division will be located at Kawnpui.
- 3. SAITUAL CIVIL SUB-DIVISION IN AIZAWL DISTRICT: This new Civil Sub-Division shall comprise the areas covered by Saitual and Suangpuilawn Assembly Constituencies with Headquarters at Saitual.
- 4. THENZAWL CIVIL SUB-DIVISION IN AIZAWL 'S' DISTRICT: This new Civil Sub-Division shall comprise towns/villages located along and West of NH 54 excluding Serchhip town with Headquarters at Thenzawl.
- 5. N. VANLAIPHAI CIVIL SUB-DIVISION IN AIZAWL 'S' DISTRICT: This new Civil Sub-Division shall comprise the areas covered by N. Vanlaiphai Assembly Constituency with Headquarters at N. Vanlaiphai.
- 6. NGOPA CIVIL SUB-DIVISION IN AIZAWL E DISTRICT: This new Civil Sub-Division shall comprise the areas covered by Ngopa Assembly Constituency with Headquarters at Ngopa.

7. W. PHAILENG CIVIL SUB-DIVISION IN AIZAWL 'W' DISTRICT: This new Civil Sub-Division shall comprise the areas covered by Phuldungsei Assembly Constituency with Headquarters at West Phaileng.

- 8. TUIPANG CIVIL SUB-DIVISION CHHIMTUIPUI 'E' DISTRICT: This new Civil Sub-Division snall comprise the areas covered by Tuipang Assembly Constituency with Headquarters at Tuipang.
- 9. TUICHHAK CIVIL SUB-DIVISION IN CHHIMTUIPUI 'E' DISTRICT: This new Civil Sub-Division shall comprise the areas covered by Sangau Assembly Constituency with Headquarters at Bualpui 'NG'.

Further, the Governor of Mizoram is pleased to create 3 (three) new Sadar Sub-Divisions for the District Headquarters of Kolasib, Serchhip and Lawngtlai as follows:—

- 1. KOLASIB SADAR SUB-DIVISION: This new Sadar Sub-Division shall comprise the areas covered by Kolasib Assembly Constituencies including Thingdawl town which is under Kawnpui Assembly Constituency. With the creation of this Sadar Sub-Division, the existing Kolasib Sub-Division is abolished.
- 2. SERCHHIP SADAR SUB-DIVISION: This new Sadar Sub- ivision shall comprise the areas covered by Lungpho Assembly Constituency and part of Serchhip Assembly Constituency comprising towns and villages located east of NH-54 including Serchhip town.
- 3. LAWNGTLAI SADAR SUB-DIVISION: This new Sadar Sub-Division shall comprise the areas covered by Lawngtlai Assembly Constituency. With the creation of this Sadar Sub-Division, the existing Lawngtlai Sub-Division is abolished.

Consequently, the territorial jurisdiction of Sakawrdai Civil Sub Division already notified vide Notification of even no. dt. 26.8.98 stands modified with the inclusion of Suangpuilawn Assembly Constituency within the territorial jurisdiction of the new Saituai Civil Sub-Division.

This notification shall take effect from the date the offices of the Sub Divisional Officers (Civil/Sadar) start functioning.
