NOTIFICATION

No. H. 11022/9/97-CADC (L), the 13th November, 1998. In exercise of the powers conferred under rule 124 of the Mizoram Autonomous District Councils (Constitution and conduct of Business of the District Councils) Rules, 1974, I Shri Adikanta Tongohangya, Chairman of the Chakma Autonomous District Council hereby make the following rules to regulate the composition and function of the "COMMITTEE ON EXECUTIVE COMMITTEE ASSURANCES" of the Chakma District Council.

RULES

1. In this rules, unless the context otherwise requires :—

- (a) "Chairman of the Committee" means the Chairman of the Committee on Executive Committee Assurances of the Chakma Autonomous District Council.
- (b) "Chairman of the Council" means the Chairman of the Chakma Autonomous District Council.
- (c) "Committee" means the Committee on Executive Committee Assurances of the Chakma Autonomous District Council constituted under rule 2.
- (d) "Executive Committee" means the Executive Committee of the Chakma Autonomous District Council.
- (e) "Council" means the Chakma Autonomous District Council.

2. There shall be a Committee called the Committee on Executive Committee Assurances which shall consist of 5 (five) members of the Council to be nominated by the Chairman of the Council.

3. No member shall be appointed to the Committee if he is not willing to serve on it.
4. The Chairman of the Committee shall be appointed by the Chairman of the Council from amongst the members of the Committee.

Provided that if the Deputy Chairman of the Council is a member of the Committee, he shall be Chairman of the Committee.

5. If the Chairman of the Committee is absent from any meeting for any reason or unable to act, the Chairman of the Council may appoint any of the members of the Committee to act as Chairman of the particular meeting.
6. A member desiring to resign his seat from the Committee may by writing under his hand submit such resignation addressed to the Chairman of the Council.
7. The quorum to constitute a meeting of the Committee shall be one third of the total number of members of the Committee.
8. The sitting of the Committee shall be held within the precincts of the Chakma Autonomous District Council House and if necessary arises to change the place of sitting to outside the Council House, the matter shall be referred to the Chairman of the Council whose decision shall be final.
9. The sittings of the Committee shall be held on such dates and at such hours as the Chairman of the Committee may be fixed.
10. The Secretary to the Council shall be Secretary of the Committee, but the Secretary shall not be a member of the Committee.
11. The term of Office of the members of the Committee shall be for a period of one year from the date of constituting the Committee.
12. (a) It shall be the function of the Committee to keep track of the Assurances given by the Chief Executive Member and other members of the Executive Committee on the floor of the House and persue them till they are implemented.
(b) The Committee shall have the power to note down and keep record the assurances made by any member of the Executive Committee on the floor of the House.
(c) The Committee shall have the power to intimate/persue the assurances to the Chief Executive Member and the other concerned Executive Members of the Chakma Autonomous District Council and the department Officers concerned so as to be informed about the accomplishment and progress of the work according to the Assurances in time with copy of implementation as a matter of proof.
(d) The Committee shall have such other function as may be assigned to it by the Chairman of the Council from time to time.

13. The information (Copy of letter) regarding accomplishment or progress of the works according to Assurances so far received/collected shall be properly recorded and presented to the Chairman of the Council atleast seven days before the opening day of each Session and such information shall also be circulated to the all members of the Committee.
14. The information so far collected by the Committee shall be reported by the Chairman of the Council to the House and circulated to the all members.
