NOTIFICATION

No. A. 12018/4/92 - P&AR(GSW), the 24th March, 1999. I exercise of the powers conferred by the Proviso to Article 309 of the Constitution of India, the Governor of Mizoram is pleased to make the following rules relating to the recruitment of the post of Deputy Project Director under State Level Monitoring Cell, Rural Development, Govt. of Mizoram, namely:—

- 1. Short title (a) These Rules may by called the Mizoram Rural Development and comunder State Level Monitoring Cell Department (Group 'A' post) Recruitment Rules, 1999.
 - (b) They shall come into force on the date of such date as the State Government may by Notification appoint in this behalf
- 2. Application. The Rules shall apply to the post specified in column 1 of the Annexure-I hereto annexed.
- 3. Number of The number of the said post(s), their classification and the posts, classificascale of pay attached thereto shall be as specified in Columns tion & Scale 2 to 4 of the Annexure-I aforesaid.

- 4. Method of The age limit, qualification and other matters relating to Rectt., age limit the said posts shall be as specified in columns 5 to 14 of and other the Annex-I aforesaid.

Provided that the age limit prescribed for direct recruitment may be relaxed in the case of candidate belonging to the Scheduled Castes/Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Central Government or Government of Mizoram from time to time. Disqualification.

No person,

- (a) who has entered into or contracted a marriage with a person having a spouse living, or
- (b) who having a spouse living, has entered into or contracted a marriage with any person shall be eligible for appointment to the said post(s).

Provided that the Governor may, if satisfied that such marriage is permissible under the personal law applicable to such person and to other party to the marriage and that there are other ground for doing so, exempt any such person from operation of these rules.

- 6. Training and Departmental Examination.
- Every Government servant recruited under these Rules shall undergo such training or pass such Departmental Examination as may be prescribed from time to time.
- 7. Power to transfer.
- Notwithstanding anything contained in these Rules, the Governor of Mizoram in public interest shall have the right and power to transfer any officer so recruited under these rules to any other post or position which is equivalent in rank or grade.
- 8. Power to relax.
- Where the Governor is of the opinion that it is necessary or expedient so to do, he may, by order and for reasons to be recorded in writing in consultation with the Mizoram Public Service Commission, through the Department of Personnel & Admn. Reforms, relax any of the provisions to these Rules with respect to any class or category of persons.
- 9. Reservation and other concessions.
- Nothing in these Rules shall affect any reservation or other concessions required to be provided for the Scheduled Castes/Scheduled Tribes and other categories of persons in accordance with the order issued by the Central Government or Government of Mizoram from time to time in this regards.
- 10. Repeal and Savings.
- On and from the commencement of these rules, all Rules pertaining to these posts framed by the Government of Assam or Governor of Assam and continued to be existence in pursuance of Government of India, Ministry of Home Affairs' Notification No. 14/21/71-HMP dated 21.1.1972 or framed by Government of Mizoram prior to the commencement of these Rules shall stand hereby repealed.

Provided that any order made or anything done or any action taken under the Rules so repeated or under any general orders ancillary thereto, shall be deemed to have been made, done or taken under the corresponding provisions of these Rules.
