A member of the State Level Co-ordination Committee so nominated under clause (f) or clause (h) of sub-Section (2) of Section 13 shall hold office for a term of three years from the date of his appointment. Terms and conditions of services of members of the Committee shall be governed by Section 14 and other relevant provisions of the Act.

Functions of the State Level Co-ordination Committee shall be to serve as the State focal point on disability matters and facilitate the continuous evolution of a comprehensive policy towards solving the problems faced by persons with disabilities and in particular:

- a) review and co-ordinate the activities of all the Department of Governments and other Governmental and non-governmental Organisations which deal with matters relating to persons with disabilities;
- b) develop a State policy to address issues faced by persons with disabilities;
- c) advise the State Government on the formulation of policies, programmes legislation and projects with respect to disabilities;
- d) take such other steps to ensure barrier free environment in public places, work places, schools and other institutions;
- e) monitor and evaluate the impact of policies and programmes designed for achieving equality and full participation of persons with disabilities;
- f) to perform such other functions as may be prescribed by the State Government.
