NOTIFICATION

No. A. 12018/74(i)/80-APT (B), the 13th July, 1999. In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Mizoram is pleased to make the following rules for the recruitment to the Post of DRILLER in Geology and Mining Wing under Industries Department, Government of Mizoram, namely :--

- 1. Short title 1) These Rules may be called the Mizoram Industries Depart. ment Group 'B' (Non-Gazetted Post) Recruitment Rules. 1999.
- They shall come into force on the date of their publication in the Official Gazette.

2. Application. The Rules shall apply to the post specified in column 1 of the Annexure hereto annexed.

3. No. of posts, The number of the said post (s), classification and the Classification scale of pay attached thereto shall be as specified in Columns and Scale of Pay. 2 to 4 of the Annexure aforesaid.

4. Method of requalification.

The age limit, qualification and other matters relating to cruitment, age the said post shall be as specified in Columns 5 to 14 of limit and other the Annexure aforesaid.

> Provided that the age limit prescribed for direct recruitment may be relaxed in the case of Candidates belonging to the Scheduled Castes/Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Central Government or by the Government of Mizoram from time to time.

- 5. Disqualification. No person—
 - Who has entered into or contracted a marriage with a a) person having a spouse living, or

who, having a spouse living, has entered into or contracted a marriage with any person shall be eligible for appointment to the said post (s):

Provided that the Governor may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for doing so, exempt any person from operation of these rules.

- 6. Training and Departmental Examination.
- Every Government servant recruited under these Rules shall undergo such training or pass such Departmental Examinations as may be prescribed from time to time.
- 7. Power to transfer.
- Notwithstanding anything contained in these rules, the Government of Mizoram in public interest, shall have the right and power to transfer any officer so recruited in accordance with these rules to any other post or position which is equivalent in rank or grade.
- 8. Power to

Where the Governor is of the opinion that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in writing in consultation with the Selection Committee/Departmental Promotion Committee through the Department of Personnel and Administrative Reforms, relax any of the provisions of these rules with respect to any class or category of persons.

9. Reservations and other concessions.

- Nothing in these Rules shall affect any reservations or other concessions required to be provided for the Scheduled Tribes, Scheduled Castes and other categories of persons in accordance with the order issued by the Central Government or by the Government of Mizoram from time to time in this regard.
- 10. Repeal and Savings.

All Rules pertaining to these posts framed by the Government of Assam or Governor of Assam and continued to be in existence in pursuance of Govt. of India, Ministry of Home Affairs' Notification No.14/21/71-HMP dated 21.1.1972 or framed by the Government of Mizoram are hereby repealed.

Provided that any order made or anything done or any action taken under the Rules so repealed or under any general orders ancillary thereto, shall be deemed to have been made, done or taken under the corresponding provisions of these Rules.
