THE APPROPRIATION (No. 3) ACT, 1999

AN ACT

to authorise payment and appropriation of certain sums from and out of the Consolidated Fund of India for the services of the financial year 1999-2000.

BE it enacted by Parliament in the Fiftieth Year of the Republic of India as follows:—

1. This Act may be called the Appropriation (No. 3) Act, 1999.

Short title.

22 of 1999.

2. From and out of the Consolidated Fund of India there may be paid and applied sums not exceeding those specified in column 3 of the Schedule amounting in the aggregate [inclusive of the sums specified in column 3 of the Schedule to the Appropriation (Vote on Account) Act, 1999] to the sum of seven lakhs twenty-eight thousand one hundred and eighty-five crores and thirty-four lakh rupees towards defraying the several charges which will come in the course of payment during the financial year 1999-2000 in respect of the services specified in column 2 of the Schedule.

Issue of Rs. 728185.34,00,000 out of the Consolidated Fund of India for the year 1999-2000.

3. The sums authorised to be paid and applied from and out of the Consolidated Fund of India by this Act shall be appropriated for the services and purposes expressed in the Schedule in relation to the said year.

Appropriation.

4. References to Ministries or Departments in the Schedule are to such Ministries or Departments as existing immediately before the 10th day of February, 1999 and shall, on or after that date, be construed as references to the appropriate Ministries or Departments as reconstituted from time to time.
