APPENDIX 'A'

GUIDELINES/FUNCTIONS OF THE STATE REGIONAL RECORDS SURVEY COMMITTEE

Object

The object in setting up of the Committee is to carry out a systematic survey of archival materials in possession of temples, individuals, institutions and bussiness houses in Mizoram and to suggest ways and means for their proper preservation, listing and utilisation by the researchers. This Conmittee will also works as Advisory Committee and Archival Council.

The Headquarters of the Committee will be at Aizawl.

ters

Tenure The tenure of the Committee shall be of two years commencing from the date of the issue of the notification. The term of the

office of the members shall also be for two years.

Meetings

The Committee will meet as often as necessary at any time and

place within the state.

Quorum

members will constitute the quorum for a meeting

and one of them will be non-official member.

Functions

The Committee will perform the following functions:

To advise the Government of Mizoram on the survey of manus-(a) cripts and documents, pre-1900 published books, rare private papers, paintings of historical, administrative, archival and cultural value in private custody, and private papers of eminent persons, old families and bussiness houses of Mizoram and their acquisitioned by donation or loan.

(b)

To induce individuals, institutions, societies and bussiness houses to send their cocuments and photographs of historical, administrative and cultural importance to Mizoram State Archives for

proper use by the bonafide Research Scholars.

(c)

To advise the Department of Archives (Mizoram State Archives) to acquired typed, photostar, Xerox microfilm copies of these important documents and books which the owners do not want

to partwith.

(d)

To advise the Department of Archives (Mizoram State Archives) to register those important decuments and manuscripts which the owners do not want to partwith.

(e)

To advise the State Government in the matter of preservation and maintenance of Public Records and on other technical matters

(f)

To advise the State Government regarding enacment of Archi-

val law.

Procedure

: All proposal for the donation, acquisition and loan of documents etc., noticed by the member (s) of the Committee will be intimated through the Member Secretary of the Committee at its next meeting for determining their historical archival, cultural or administrative value.
