The Objects of the Council shall be to promote and protect within the State the rights of the Consumer such as :-

(a) The rights to be protected against the marketing of goods and services which are hazardous to life and property.

(b) The right to be informed about the quality, quantity, potency, purity standard and price of goods or services so as to protect the Consumers against unfair trade practices.

(c) the right to be assured whatever possible access to a variety of goods and services at competitive practices.

(d) the right to be heard and to be assured that Consumers interest will receive due consideration at appropriates.

(e) the right to seek redressal against unfair trade practices or restrictive trade practices or unscrupulous exploitation of Consumer Education

(f) the right to Consumer Education.
