ORDER

No. 76/MIZ-LA/99:— Whereas the Election Commission is satisfied that each of the contesting candidate specified in column (4) of the Table below at the election specified in column (2), held from the constituency specified in column (3) against his name has failed to lodge an account of his election expenses or in the manner required by law as required by the Representation of the People Act, 1951 and Rules and orders made thereunder as shown in column (5) of the said Table; and

Whereas, the said candidates have not furnished any reason or explanation for the said failure even after due notice and the Election Commission is thus satisfied that they have no good reason or any justification for the said failure;

Now, therefore, in pursuance of Section 10A of the said Act, the Election Commission hereby declares the persons specified in column (4) of the Table below to be disqualified for being chosen as, and for being, a member of either House of the Parliament or of the Legislative Assembly or Legislative Council of a State for a period of three years from the date of this order.
