NOTIFICATION

No. A. 12015/1/98-SAE(Part), the 15th February, 2000. In the interest of public service and in exercise of the powers conferred under Proviso to Article 309 of the Constitution, the Governor of Mizoram is pleased to make the following scheme namely –

- 1. Preamble : This is formulated for giving scope for regularization of Muster Roll Employees to regular posts under the Government of Mizoram in the light of the Hon'ble Spreme Court's directive reported in AIR 1992 SC 2130 as well as the Judgement and Order passed by the Hon'ble Gauhati High Court (Aizawl Bench) on 5.5.99 in W.P(C) No. 61/98 in respect of Lalzawmliana and Ors Vs State of Mizoram & Ors.
- 2. Short Title : This scheme shall be called "Regularization of Muster Roll and Commence Employees in the Secretariat Administration Department of ment the Government of Mizoram Scheme, 2000.

It shall come into force at once.

- Application : This scheme shall apply to all Muster Roll Employees in Group 'C' and Group 'D' categories under S.A.D., who were duly employed by means of engagement-order/cards issued by the competent authority.
- 4. Regularization. Roll capacity in Group C' or D' Categories in the Secretariat Administration Department for at least 7 (seven) years shall be eligible for regularization in a corresponding regular post prescribed for direct recruitment in the concerned Recruitment Rules, subject to availability of vacancy.

Provided that such Muster Roll Employee possesses the required educational and other qualifications prescribed in the relevant Recruitment Rules.

Provided further that such regularization shall be made subject to satisfactory performance reports for the last 5 years, prepared by the Controlling Officers.

(ii) Such regularization shall be considered in order of the length of service in the Muster Roll capacity.

(iii) 25% of vacant posts under direct recruitment may be reserved for Muster Roll Employees or as the Government may determine from time to time.

5. Condonation : Age of a Muster Roll Employee may, while considered for of Age. appointment to a regular post, be condoned by the Government unless such an employee was already overaged at the time of initial engagement, for such regular appointment.

6. Regularization not as of right is a matter as of right. Notwithstanding anything contained in this Scheme, such regularization shall not be claimed by any Muster Roll employee as a matter as of right.
